

SCHOOL UNIFORM POLICY

1. Introduction

- 1.1 It is our policy that all children should wear school uniform when attending school, or when participating in a school organised event outside normal school hours. We provide a complete list of the items needed for school uniform in our school prospectus and on our school website.
- 1.2 Our Hartburn Primary School uniform helps to build pride in our school, enhances the school's reputation and makes our children stand out as smart, proud and confident members of our wider community. We have produced the following guidance to keep our uniform streamlined and simple for parents/carers. The majority of our school uniform can be sourced from generic school clothing suppliers and local shops and supermarkets. We intend for the uniform to be as cost effective a possible for our families.

2. Aims and objectives

- **2.1** Our policy is based on the shared understanding that a school uniform:
 - a. promotes a sense of pride in the school;
 - b. engenders a feeling of community and belonging;
 - c. is practical and smart;
 - d. identifies the children with the school;
 - e. is not distracting in class (as fashion clothes might be);
 - f. makes children feel equal to their peers in terms of appearance;
 - g. is regarded as suitable and good value for money, by most parents;
 - h. has been designed with health and safety in mind.

3. School uniform

3.1 The DFE guidance does not require Governing Bodies to carry out documented market research. However, in accordance with the DFE guidance, cost considerations and value for money have been given the highest priority by the Governing Body in considering the school uniform. As part of this, the Governing Body have agreed two suppliers.

4. Uniform purchase

- **4.1** Specific items of school uniform with the school logo embroidered on them such as jumpers, cardigans, ties, school book bags and PE bags can be ordered from the school uniform suppliers or purchased directly from the school uniform supplier premises; Elizabeth's Embroidery and Motif8.
- **4.2** School ties can also be purchased from the school office.
- **4.3** The Governing Body believe that the use of two suppliers will keep the cost price competitive and, most importantly, affordable for all families.
- **4.4** With affordability in mind, the Governing Body have also kept the number of compulsory items of clothing to an absolute minimum. These are:
 - a. School Jumper or Cardigan with Embroidered logo
 - b. Tie (Full or elasticated)
 - c. PE Polo Shirt with Embroidered logo

Note: Blazers and other logoed items are available but are not compulsory.

- **4.5** Parents/carers may then choose to purchase the remaining items from local supermarkets and other high street stores.
 - a. White shirt
 - b. White/Grey socks
 - c. Gingham dress blue (summer)
 - d. Grey shorts (summer)
 - e. Grey trousers/skirt
 - f. Black plain shoes or black plain trainers with fastenings

Note: High heels and wedges are not permitted

- g. PE kit
- **4.6** Children arrive in their PE kit on days when they are timetabled to have PE lessons; this reduces washing, the need for a PE kit bag and lost PE kit items. Without the need to change during the school day, this also increases time for physical activity.
- **4.7** The introduction of the logoed PE top is in response to comments previously made by parents, grandparents and teachers regarding the "smartness" of our children when representing the school at previous sporting events/sports days.
- 4.8 Only the logoed polo shirt is compulsory. Shorts, tracksuit bottoms and sweatshirts/hoodies can be purchased from any other store but must be plain grey/black. They must not have branded logos and shorts must be of appropriate length and visible beneath the t shirt and/hoodie.
- 4.9 Please ensure your child wears their school jumper or cardigan over their PE kit on PE days.
- 4.10 The school has also purchased 'school hoodies' and kits to be loaned and worn by children representing the school in external events.

5. EYFS uniform

- 5.1 EYFS can wear a more relaxed version of the school uniform. The children in Nursery and Reception can wear a white polo shirt, grey elasticated school trousers/skirts with the school jumper/cardigan.
- 5.2 Items with a Hartburn logo are optional. Ties in EYFS are also optional.

6. Financial support

- **6.1** Families needing financial support are always encouraged to approach school. Requests are dealt with sensitively and in the strictest of confidence.
- 6.2 In addition, The Friends of Hartburn Primary School (FOHPS) also provide 'preloved' items and run regular stalls to assist parents/carers to purchase uniform and event items such as Christmas jumpers and Halloween disco costumes. 6.3 Details of stalls are also shared via the weekly school newsletter, 'The Hartburn Herald'.

7 Name labels

- **7.1** We strongly urge all parents to label all items of their children's clothing as this assists when items of uniform are lost during the day.
- **7.2** The suppliers of school uniform will, for a small charge, add a child's initial's in embroidery to a school uniform, jacket or book bag. Only a child's initials may be added to uniform not full names or nicknames.

8 Jewellery

- **8.1** On health and safety grounds we do not allow children to wear jewellery in our school. The exceptions to this rule are small (not dangling) ear-ring studs in pierced ears, and small objects of religious significance (such as a crucifix on a chain) and watches.
- **8.2** All jewellery, including earrings, must be removed (not covered) during PE and games on health and safety grounds. School takes no responsibility for their safe keeping.
- **8.3** If children are getting their ears pierced, we recommend they have this done at the start of the summer holiday and not during term time.

9 Make-up

9.1 Children should not come to school wearing any form of make-up; this includes tattooed/cosmetic eyebrows, false tan, false eyelashes/eyelash extensions, nail varnish, false nails/nail extensions. Henna is permitted for occasional religious celebration.

10 Hair

- All children are requested to tie hair up where it is long enough to do so. This is for both health and safety reasons and to look smart and ready for school. Hair must be tied up in PE.
- 10.2 Oversized and brightly coloured hair accessories are not allowed, and pupils will be asked to remove them.
- 10.3 In swimming children must wear a swimming cap.
- 10.4 Head scarves must be plain navy blue or black.
- **10.5** Extreme, non-regulation hairstyles are not part of school uniform and should not be worn. These include:
 - a. Patterns cut into the hair
 - b. Skin fades are allowed, but should not be extreme
 - c. Hair that is long in parts and very short elsewhere
 - d. Hair dyed or coloured either wholly or partly, in a non-natural hair colour.

11 Footwear

- 11.1 The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes with platform soles or high heels in school, so we do not allow this.
- 11.2 Trainers are permitted with uniform to allow children to be active during break and lunch

times, if they wish. However, these trainers must be plain black in keeping with the smart appearance of our uniform.

11.3 Plain black or coloured trainers can be worn on PE days.

12 The role of parents

- 12.1 We ask parents who choose to send their children to our school to support our school uniform policy. We believe that parents have a duty to send their children to school correctly dressed and ready for their daily schoolwork. Parents should ensure that their child has the correct uniform, and that it is clean and in good repair.
- 12.2 If any parent would like the school to modify the uniform policy, they should make representation, in the first instance, to the Head Teacher. The school welcomes children from all backgrounds and faith communities. If there are serious reasons, for example religious objections, why parents want their child to wear clothes that differ from the school uniform; the school will look sympathetically at such requests. Similarly, should an item of school uniform prove problematic for a pupil with disabilities, then parents are invited to draw this to the attention of the Head Teacher. The school will not treat pupils with disabilities unfavorably (please refer to our Equality and Diversity Policy for more information).

13 The role of governors

- 13.1 The Governing Body supports the Head Teacher in implementing the school uniform policy. It considers all representations from parents regarding this policy, and liaises with the Head Teacher to ensure that the policy is implemented fairly and with sensitivity.
- 13.2 It is the governors' responsibility to ensure that the school uniform meets all national regulations concerning equal opportunities, and that our school uniform policy is consistent with our policy on equal opportunities.
- 13.3 Governors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hardwearing, safe and practical.

14 Pupil non-compliance

14.1 The Head Teacher, or a person authorised by the Head Teacher, may contact parents when the school uniform code is not being followed. If the pupil continues to breach uniform rules in such a way, parents will be contacted and must bring the correct uniform to school. If the matter continues, the school may consider other actions in response to breaches of the uniform policy.

15 Monitoring and review

- 15.1 When monitoring this policy, through its committee work, the Governing Body will:
 - a. seek the views of parents, to be sure that they agree with the policy, and support it;
 - b. consider with the Head Teacher any requests from parents for individual children to have special dispensations;
 - c. require the Head Teacher to report to the governors on the way the policy is being implemented.
- 15.2 This policy will be reviewed by the Governing Body every two years or earlier if necessary.
